


At 9am 24th June, 1101 responses have been submitted.


Council's decision to provide FootballSSG with insufficient sports field allocations will prevent one third of players (1,000 people) from participating in its Warriewood-based competitions. This decision is unacceptable and should be reversed, immediately.


Council's decision to restrict FootballSSG's access to one demonstrably unsuitable sports field on which to operate its Warriewood-based competitions endangers the continuation of those competitions. This decision is unacceptable and should be reversed, immediately.

Council's refusal to instead allocate FootballSSG with one day per week access to three suitable grass fields on which to operate its Warriewood-based competitions is entirely inappropriate, particularly given Council's written advice to Councillors (Angela Casey, 7 May 2025) that one day per week of FootballSSG on a grass field is sustainable.




Council’s position that in future no sports that have a high impact on fields will be permitted to play on natural grass fields and rather will only be permitted to play on artificial turf fields is nonsensical and unworkable given the limited number of artificial turf fields that exist.


Decisions that limit access to sporting activities are detrimental to the community's physical and mental health and well-being.





Council must allocate FootballSSG with enough suitable fields so that everyone who wants to play can do so.



FootballSSG has already put forward a practical, in-principle plan to help fund and fast-track two new multi-sport artificial fields. Until those come online (which will take years), Council must immediately:

- Reverse its April 2025 decision to ban all high-impact sports from natural turf fields,
- Reinstate adequate Warriewood-area grass fields so every player and volunteer ref can participate safely,
- Work collaboratively with FootballSSG - and all local sporting groups - in good faith to secure permanent, sustainable solutions.

WE DO NOT HAVE ENOUGH ARTIFICIAL TURF FIELDS FOR SUMMER AND WINTER SPORTS IN THIS AREA!. Winter soccer has recently been impacted with game cancellations due to extreme wet weather. In the mean time use our extra rate money to replenish the fields (ie Rat Park) until new artificial fields are built and available!. Keep our kids engaged in sport!. All ages!. All year round!. As council rate payers we expect that our children should have access to fields to play their sport. Physical activity is essential to children's and adults wellbeing and to take away this opportunity for our kids to engage in a sport that they are passionate about will be very detrimental.

Please assist when keeping this organisation going as it important for the youth of the northern beaches

Our children's mental health and wellbeing need fields to play their sports. At this point the whole restriction of grass fields near where we live is absolutely ridiculous. What kind of future is this? For gods sake let us have the access to fields.

The amount of antisocial behaviour has been increasing in the northern beaches. There are various reasons for this but one is that adolescence are disengaged and bored. I have two young boys and very much think their ongoing involvement with sport and a sporting community, can help ensure they feel a belonging on the beaches. SSG is a big part of this and if this and other sporting opportunities disappear, I think in the years to come, we will be seeing even more problems arising from young teens.

We pay our council rates so that we can access and enjoy local facilities. So why is the Northern Beaches Council actively gatekeeping our access to local playing fields?

Our children need opportunities to be fit, healthy, and to develop important skills like teamwork through sport. Yet the NB Council is making it harder and harder for them to do that. Are we really going to force all sporting competitions - Touch Footy, Winter Soccer, Rugby Union, Rugby League, Cricket, Softball, AFL - onto artificial turf? These are high-impact sports; are you planning to replace every single field with synthetic grass?

What's the alternative? Limit access to fields and push kids away from positive, structured activities? That's the fastest way to end up with more kids hanging around the streets with nothing to do - and that's already a problem. Youth crime and gang activity are rising on the beaches. Removing safe, structured sports options like summer soccer will only make things worse.

Parents are trying to do the right thing: enrolling their kids in sport to keep them active, healthy, and out of trouble. But now you're making that harder, too. There are already far too few activities and facilities for teens on the beaches - why make it even harder for families who just want the best for their kids?

We pay our rates to support local facilities. NB Council: do better for our kids.

Summer soccer is a vital and valued activity enjoyed by thousands of children in the Narrabeen, Warriewood and Mona vale area. It is so well organized which always thousands of children to participate over various days.

It won't solve the problem this season but there is a large amount of flat grassed space that is mostly used to park cars at North Narrabeen Reserve. Natural turf pitches have been fine for decades. If this needs to change in the future, fine, but not until the infrastructure is first put in place. I grew up in Grafton where the pitches were rock hard dirt with minimal grass. In Brazil, India and many countries they play on dirt. Kids already have reduced their activity. This is the silliest decision I have ever heard. I pray you reconsider after understanding all the ways mplications.

Restricting access to football, one of the most popular sports in the world is honestly an embarrassing proposition from council. This is the councils chance to pave the way in standing tall and providing the kids with a healthy active lifestyle and better outcomes for positive mental health!!

The councils decision is shocking. Especially as so much of the kids winter soccer competition gets washed out as council say the kids can't play on the wet grass!! I have been living on the northern beaches my whole life playing sport myself and my siblings and now my own 3 children. Narrabeen sports oval is too small, both synthetic and grass. The grass one isn't flat enough, lots of unsafe holes, and the synthetic will be very hot in summer

This is absolutely not the right decision. Football SSG is an integral part of our lives.

Sport alleviates mental health! It's one of the biggest issues we are facing at this time. Don't deny our kids something that can give them a coping mechanism for their mental health, fitness, comraderie.

SSG soccer is a highlight of my children's year, please don't take that away.

Do the right thing

Very disappointing from the council. The football SSG competition has always been a tremendous opportunity for people of all ages to be outside with friends, having fun and exercising. Especially in a changing society which is being more oriented around screens, kids are growing up on ipads or gaming instead of being outdoors. The competition is a tremendous excuse for everyone to be outdoors having fun, which is substantially important for their health. It's also at a time where other team sports competitions are finished, so majority of kids spend their afternoons indoors. Such a shocking decision from a council which I thought was all for physical/mental health, and being outdoors. I am also feeling for stuart cole who has worked so hard year after year providing to our community with this incredible competition. So disappointing!

In politics, optics are everything. In this case, my view of this is that council is does not care enough to warrant appropriate review of requirements, but are quick to increase rates by an extraordinary amount.

Please support our local community to engage with sport and support our well being by giving more access to sporting fields asap

Unacceptable. Especially following winter season after season of washed out soccer/ league / rugby matches because many of the grass fields cannot cope with the deluge of water. The drainage is appalling and this problem will not go away. Wet winters are looking more probable and a workable solution must be implemented. That is either drainage, or its artificial turf sporting fields. This is the physical and mental health of our community at stake. Step up and take action that will positively benefit our community - especially one like the Northern Beaches where sport is an enormous part of most members.

This is no longer acceptable.

Season after season, we've watched soccer, rugby, and league matches get cancelled due to waterlogged fields - especially throughout our increasingly wet winters. The current drainage systems simply aren't coping, and this isn't a short-term issue.

It's time for a long-term, workable solution: improved drainage or the installation of all-weather synthetic turf fields. The physical and mental health of our community depends on consistent access to sport and outdoor activity.

On the Northern Beaches, where sport is central to so many lives, we need leadership that prioritises action - not just talk. Let's invest in the infrastructure that keeps our community active, connected, and resilient.

You are upping everyone's rates hugely but taking away something that parents and kids look forward to. Factor returfing into your enormous budget so our kids can play soccer. Seems like you're encouraging obesity in kids by essentially taking away sport.

The decision to restrict the fields is so detrimental to our community. First in first serve is not ok. So many kids will miss out. Soccer is often their first exposure to team sport and the summer soccer competition is especially good for that. In a world where we are trying to encourage kids to get off screens and out in nature this is the exact opposite of what we are trying for. If this decision holds it will be beyond disappointing.

Artificial turf is a poor environment choice, painful to fall on and more annoying to play on as the ball bounces and skids way too far. It's ridiculous to suggest that high impact sports should be played on it.

We need a local competition for summer soccer given the huge popularity in the sport, council needs to accommodate the large number that want to play

I am absolutely shocked and disappointed that northern beaches council have taken this position. It makes no sense. What are playing fields for? Physical exercise, particularly team sport help address and combat mental health and obesity issues which are both at epidemic levels in Australia.

My daughter Amalia has participated in footballSSG summer soccer for several season's. Last year was her most important as she was in yr 12 at Barrenjoey High and winter and summer soccer was her only sport activity away from the study grind of the HSC. It was absolutely vital to both her physical and mental health, as well as many of her classmates who also participated. She has continued to play soccer (open women's Div) since leaving school.

Govt. at all levels should be encouraging and incentivising participation in sport, not restricting or cancelling it. The long term cost and social benefits will be far greater if council work toward the community's best interests, rather than against it.

When I first moved to the Northern Beaches 8 years ago, I signed up for Football SSG (in my mid-teens). Years later, as a young adult, I am stilling playing FootballSSG. This summer soccer competition has been a part of my life for almost a decade, and I have built and maintained friendships through my participation in it. It has been a great physical outlet, from after school to after work, and during the winter soccer break. The idea that up to 1/3 of players may not get to participate if FootballSSG is moved to Narrabeen Sports High is not only very disappointing, but somewhat distressing as well, as I'm worried that my friends, or myself, might not get the opportunity to play this year or in future. The parking around NSH is wholly insufficient as well, and would put immense pressure on local residents and potentially pose a safety risk with people having to park on/so close to a main road. In a post-COVID, digitally driven world, it is more important than ever to keep children out and about playing sports. Try and picture the 1000 members of our local community, from young kids to adults, who will miss out on this fun and friendly competition. I urge Council to reconsider their decision and protect the needs of our community, and recognise the value that FootballSSG provides.

Our kids have already suffered enough social distancing from covid and when they're finally connecting again with their peers through sports, council wants to limit this? Summer soccer has been a huge part of our family health and wellbeing and it's a real shame it won't be able to engage all the community members that have been involved in the past years! Please allow Summer Soccer to continue in Warriewood, for our future generations mental and physical wellbeing!

How can council remove access to NBC parks and then dump this competition on an asset they don't even own/maintain? NSHS is owned by DoE and maintained by the school, how can council dictate that games should be held there without a concept of what is already held there. The NSHS turf is used morning/day/night 7 days a week already. What impact will this decision have on other sports? This 'alternative' doesn't make sense.

People's ability to practice sports should be expanded, not limited. Our health system is overloaded with mental health issues, and it's widely known that team sports are a great option to keep people healthy physically and mentally. What's the reasoning behind this decision? I cannot think of any good one. Has there been any consultation? We didn't hear anything. Team sports bring communities together, it seems you are trying to pull them apart - why?

Council has previously been advised that synthetic fields are detrimental to the environment and therefore Council are no longer willing to invest in synthetic fields. It would therefore follow that Council intends to ultimately deny all "high impact" sports from playing on any Council fields. This seems non-sensical. There must be a way to rotate the use of playing fields and other open spaces to ensure all members of our community can play the sports they love. As the density of housing increases. The demand on these spaces will increase. If there are organisations out there, who are willing to help fund initiatives to improve and maintain grass playing fields, why won't Council take advantage of that?

So we pay more rates only to have services taken away. Think of the kids not just your bonus package!

We need to encourage our kids to play team sports not take away opportunities for them

Dear Council, please allow Northern Beaches residents the opportunity to participate fully in their preferred sports by providing adequate access to playing fields, regardless of the surface. No children should be prevented to join a sporting competition or participate in sports that they love because Council has unreasonably restricted access to public space.
Before restricting access to grass playing fields, make more artificial fields available. In the meantime, please provide rate payers with access to their playing fields without these restrictions.

Rat park is perfect for SSG. It shouldn't be used only for rugby, it's a council owned facility that goes unused for large parts of the week and year. Time to use all council space fairly amongst codes. No parking and suitable bathrooms is completely ridiculous putting safety and cleanliness at risk.

The kids enjoy playing in the grass, fake grass fields are slippery, dangerous, hurt when you fall. As above there are not enough services on the fields suggested in regards to public toilets, parking, electricity.
I understand that maintenance of grounds for sporting events is getting harder with increased rainfall and participation levels. However, it would make sense to bring this rule in AFTER you have

worked with the private sector to build adequate facilities for the community to use. This doesn't have to be funded by council, but they should facilitate getting these sporting facilities approved quickly. Then you can pass the responsibility to the private sector to manage. We need our kids to play. It has saved my daughter from depression and being lonely.

Please listen to your electorate, we need our sporting fields and work the groups who have offered to help.

Adults and children love summer soccer. As a coach and a player, it is by far the most popular game in terms of enjoyment. We need more summer soccer and not less.

Council should read its own Community Strategic Plan (CSP) which states that "Living well means...taking part in sports" (p19) and that its desired trend for "Ability to view and participate in sports...in the local area" is "Maintain/Increase" (p39). Preventing children and adults from continuing to play FootballSSG clearly goes against what is written in the CSP - so is it just lip service from Council?

Given rising temperatures and summer soccer being by definition a summer sport, the proposal to run these activities on hot summer days could lead to heat/burn injuries as seen by other councils who have tried this. Sustainability wise, this is also a poor decision.

Australian society is founded in the principle that public sporting amenities are abundantly available for the community to use. The current stance of the council is at odds with this and not in the interests of the councils constituents.

Wasting council resources like the refurbishment of North Manly tennis courts that nobody uses and later complaining that there are not enough funds to maintain the fields shows that nobody is doing a good long term analysis of the necessities of the council. There are ways to reduce the expenses that don't impact the population of the northern beaches.

Council needs to address the drainage problems at so many of the sporting fields. They only need to look at Harbord Oval as an example of the positive impact drainage solutions create. Ridiculous proposals by council

Sport plays a vital role in building strong, healthy communities by fostering connection, inclusion, and wellbeing. Ensuring access to council-run fields and facilities is a core responsibility of local government - this is exactly why councils exist: to support the everyday needs of their communities. Councils are here to serve the people. My husband is a green keeper by trade and his love of turf I understand the concerns but with proper management it is possible. What else does WArriewood get used for that FootballSSG is obstructing. My other son played cricket in summer and field use didn't impact him. What will this field be used for other than a dog walker. And will you also not allow the local NNPS to use this for sport? I have a child at that school who also plays soccer every lunch time and a large factor in his happiness at school and creating friendships.

It is an absolute disgrace that the council feels they have the right to restrict access to facilities for young children when its socio-economic benefits have been proven time and time again to improve the economy and well-being of the community.

All the kids love SSG it would be awful to stop it

Pleaae reconsider making changes that will directly effect communities on such large scale. Sport is the glue that binds us all, all should be done to maintain, develop and keep access to all fields.

NB Council is pathetic. Always display lack of collaboration with experts or locals and common sense is not applied when decision making. Where are the astro turf fields??????
NB council is oblivious to the on going effects of continuous bad decision making for our kids and the community. Never ending!.. My kids love summer soccer and summer touch football.

Playing on a synthetic turf in summer is very hot under foot especially for young children not to mention the grazing you get when falling on the synthetic turf.

What are we paying our increased rates for exactly?

I have two girls who were hoping to start playing this season and are not involved in any other sports, this is what they wanted to do and feels most accessible and familiar as a new player. They will be gutted they likely won't be able to play if these bans are enforced. It's not as simple as choosing a different sport as not every sport is suitable or of interest to every child, and as a parent I was happy they wanted to participate in this form of physical activity as part of a healthy lifestyle, and also for the opportunity for social development it provides.

I also actually oppose installing synthetic turf all over the NB. Synthetic turf is linked to environmental toxicity and health concerns and as a lifetime NB resident I would be horrified to see grass areas replaced with synthetic turf all over the NB, regardless of whether I had children in sport or not. Our playing fields should be left as natural grass which is better for people and the environment, they have served our community for decades and are there to be used not just looked at.

Removing access to fields for large numbers of the community just drives home the idea that the council places its own agenda and priorities above what the community actually wants and what our rates and sports fees pay for. So many projects have been proposed by council (with money spent on these proposals) that are rejected by the community (and were never requested by the community?), while existing resources currently used by large numbers of the community and with clear demand, are being taken away. Reducing access to sporting facilities is incredibly foreign to the culture of the Northern Beaches. "

Not only is FootballSSG an excellent provider of local sport, they facilitate a major community event through the summer soccer program. The community would be negatively impacted by removing or limiting this offering. It is the Council's responsibility to encourage and enable community engagement and particularly opportunities for youth and adult sport.

I don't understand the rationale for moving the sports to synthetic pitches. My strong preference is to put in adequate drainage and maintenance on the existing grass fields (Frank Grey and Mike Pawley fields as well as the recent drainage added to half of Harbord Park demonstrate it can be done) rather than build more synthetic pitches that have huge environmental impacts such as microplastic pollution and get extremely hot in the summer.

The football SSG competition is an integral part of our yearly sport commitments. It has given my son and his friends a stronger connection to other kids in their community, built their confidence and self esteem and provided them with an outlet throughout the year. To lose it would leave them (and plenty of other kids and parents) bitterly disappointed and seeking alternate outlets, most of which I'm sure will be far less beneficial to their long term social, emotional and physical health.

How can we not invest in kids' sporting activities, especially when they are more important than ever in today's world? Getting children out and active is not just about physical health, it is also about their mental and emotional wellbeing.

Sports like football offer so much more than just learning how to pass or score. They teach resilience, team spirit, communication and the value of showing up for others. They build confidence, discipline and a sense of belonging, which many kids are missing in our increasingly digital and fast paced lives.

We often talk about preparing our kids for the future, and this is part of it. Supporting grassroots sport is one of the most meaningful investments we can make.

Cannot believe Council is imposing these restrictions. Our poor young people have enough to deal with!

Sport is an integral part of young peoples (and older) lives on the northern beaches

Council should be doing everything it can to promote local youth participation in sports and outdoor activities including supporting competitions such as FootballSSG. FootballSSG is a well-organised community competition that brings kids and parents together. The Northern Beaches Council's abrupt decision to ban high-impact sports like FootballSSG from natural grass fields isn't just tone-deaf - it's an outright betrayal of the families who fund these facilities through their rates. You've been given solutions (including financial offers to cover maintenance and new fields), yet you've chosen to ignore every compromise. Why?

You're Ignoring the Real Costs. This isn't about grass - it's about kids losing access to fitness, friendship, and mental health support. Studies prove team sports reduce youth anxiety and depression. Yet Council's response? ""Too bad.""

- Reverse this decision immediately until proper infrastructure is built.
- Publicly disclose field maintenance costs and long-term plans. If it's ""too expensive,"" show us the math.
- Our kids deserve better than excuses. Fix this.

Do better NBC

As a parent of two children who both play in this local soccer competition, I am deeply disappointed and dismayed by the council's decision to cut access to playing fields. At a time when young people are facing unprecedented levels of anxiety and mental health challenges, team sports like soccer offer critical outlets for connection, physical activity, and emotional wellbeing.

This decision is not just short-sighted - it's a profound letdown to the families who rely on these community programs to keep their kids active, supported, and engaged. Local sport is one of the few remaining ways that children and teens can build resilience, form friendships, and feel a sense of belonging.

For a council that is charging residents record-high rates, it's incredibly disheartening to see those funds not being reinvested in the wellbeing of our children. Cutting a much-loved and well-attended competition feels like a slap in the face to local families.

I urge the council to reconsider this decision and to demonstrate a genuine commitment to supporting young people in our community. Our kids deserve better.

Council needs to invest money on the drainage of our sporting fields across the Northern Beaches, particularly at Curl Curl playing fields, where thousands of kids train and play weekly. Due to climate change and more rain we need at least 2 artificial turfs in the Curl Curl area to enable more kids to play as soon as the rain starts in April, which is the start of the winter sport season. Our kids are feeling really low and disappointed when the long awaited soccer/AFL/Rugby/Netball season starts and their trainings and games are cancelled many weeks in a row. So I am shocked to hear that there is talk about restricting sports played on our playing fields, when the opposite should be happening, which is to create more parks and playing fields and also artificial turfs, so our kids can be outside, exercising, socializing and developing their sporting talent.

I have my full support of Football SSG, who is the only summer soccer program in the area and it is run smoothly, very popular and loved. I don't know any kids who hasn't played in this comp yet. It gives a fabulous opportunity for our kids to continue playing and practicing soccer through the year. We are very grateful for them. Please do not take away sport from us, all our kids do is go to school and play sport. Let them play more!

More artificial turf are needed in Warriewood asap especially with more and more unpredicted weather in the future. Boondah fields between NNPS and the square have no proper drainage. Other Boondah playing fields are uneven and full of holes see Field 1. The holes should be filled up with new turf to prevent injuries. Also surface needs to be evened out. Further all proper soccer fields should have underground drainage to allow play during rain and periods of extended rainfall. Please confider not just the health and social benefits for our children to play this sport, but also to the individuals who are employed to referee games who will also be affected by this decision.

I agree entirely with this survey and all its points, especially the need for grass sports facilities on the Northern Beaches and the health and mental health benefits of sports, especially for youth.

It is disappointing to think that a knee jerk reaction could have such long term negative effects on council payers and their children. Denying children the right to play sport seems ludicrous in an age where more and more children are looking at devices rather than playing outdoors.

Having a large playing base, in close proximity to many homes, meant interacting with lots of other friends and acquaintances that she otherwise would not have. Keeping the community based competitions like this viable is vital for the community at large. Please reconsider this decision.

My son benefitted hugely from participating in Football SSG last year- physically getting out to play, socially bonding with kids from school and mentally getting a confidence boost for his soccer skills. I would be hugely disappointed if we couldn't participate in future or if it was not in the same organised manner as last year.

Artificial turf is NOT the answer. We deserve the right to play sport on natural surfaces, grass. The micro plastic beads which form a large part of the artificial turf surface are a toxic marine hazard. Given the amount of rain and proximity to creeks, wetlands, the lagoon and open ocean, the council is being highly negligent in respect to the environment in addition to the mental and physical health of children, youth and adults who would be otherwise engaged in healthy outdoor sports on natural land, grass. This is nonsense of the highest order.

I've been playing & refereeing football on the northern beaches for 20+ years at Club level and playing & refereeing with Football SSG, PittwaterRSL Futsal courts, MWFA @ Cromer Park for the same duration. Artificial turf fields are also toxic to children and community and pets. you can sight a lot of research here, <https://pmc.ncbi.nlm.nih.gov/articles/PMC10262297/> and here <https://pubmed.ncbi.nlm.nih.gov/35948114/> amongst other key reputable medical databases available online. Please consider these items moving forward, the NOrthern beaches is also a major catchment for up and coming Rugby players who utilise the fields ongoing and we have several professional clubs in the area and pathway programs available. futbol/soccer and rugby kids also dont play actual field games on artificial turf, it's grass when in competition usually, so that it's actually real. maintenance of turf fields is not only concerning regarding upkeep, draining and due to it's toxic nature will cause more harm than good and workers working around the turf are aware and will become aware of the implication of toxicity to their health.

More artificial fields needed

I also do not want to see the local area covered in artificial turf fields. It is environmentally destructive and not necessary.

Northern Beaches is a sporting mecca for kids on the weekends, providing an excellent opportunity for them to learn to work as a team, maintain good health and fitness, meet new friends etc. NB Council is asked to provide a very basic level of service and is requesting a 25% increase in rates from the community during a cost-of-living crisis. My sons have been involved in local sport for 18 years - why is this suddenly an issue ? Time for council to undertake a more robust prioritisation of where our rates are being spent and make sure the majority of the community's needs (like this one) are taken care of.

This is the only sport our boys play for exercise and cutting out access to the fields without an alternative seems premature. Please work to sort out alternative replacements before removing access to grass fields.

Sport is an essential component of wellness & is healthy for all ages, stop getting in the way of good things for your community, your job is to foster sport in community, not inhibit the progress.

Artificial turf heats up and has a higher than ambient temperature. It is not nice to fall on It smells like petrol. It is not robust. Shortsighted proposed policy done without research or thought. Must be discarded!

Make is better

Organised sport is an essential part of every community, particularly for children. Any attempts to limit access to much loved and wanted sports activities is completely unacceptable. We cannot teach our children that physical activity and movement, alongside community and working in teams, are essential parts of a good quality of life and then cut their access to these resources.

The proposals offered by FootballSSG to Northern Beaches Council need to be heard in full and taken in good faith for consideration. As a society we often ask for solutions to problems, rather than just whinging. This is what FootballSSG has done by consulting with their community as well as other parts of the Northern Beaches sporting community to find some appropriate solutions ... only for our Council to shut the door on any such discussions.

How can any council member "elected or employed" say they are working for the community when they behave in this manner? They can't.

The proposal to move to FootballSSG to Narrabeen Sports High's single synthetic field is mind blowing. This site has no parking, limited bathroom facilities and is unable to accommodate the number of players that wish to register for the summer soccer competition. It is not a viable solution to the intensity concerns Council is spouting as a reason for limiting the FootballSSG's access to community resources "it can't even accommodate the competition.

It is time for Council to sit with the FootballSSG organisers and the sporting community at large in good faith to hear some of the practical solutions that will enable everyone who wishes to participate in the summer soccer competition to be able to do so. These solutions combat the intensity concerns of Council and have been developed to ensure that kids (and adults) are able to participate in team sports within their communities.

Anything else is unacceptable.

The amount of joy and excitement SSG brings to so many people will be extremely impacted by this decision. I have played SSG for 16 years and would be devastated to see it gone and for younger generations not to experience the excitement.

Artificial turf is awful for kids, causing a lot of burn injuries particularly for sports like rugby/football

Council - use some of your massive rates hike to install more synthetic fields.
Let kids play sport!

Football SSG gives kids of all ages, genders and abilities the opportunity to continue to develop their soccer skills in a competitive but inclusive environment outside of the traditional soccer off season. This competition is extremely well run and the kids love playing in it. Government organisations should be encouraging the expansion of these types of initiatives, not blindly imposing restrictions and reducing player numbers. Grass roots soccer and other sports need all the support they can get!

The use of artificial fields for sports is completely unreasonable and unsafe. There is a proven greater incidence of ankle and knee injuries in sports played on artificial surfaces compared to natural grass. Additionally greater heat is generated by synthetic fields, thus increasing the risk to kids of heat related illness.

Council. You don't want to spend \$40,000 on field maintenance. Yet you will barge into Avalon & ruin a perfectly fine village & road. Using sub-standard contractors that will be rehired for years to come to resurface a road that worked perfectly before. Start making logical decisions on how to save money & leave our kids sport out of it!

My son is now 17 and has HSC but spend over 5+ years playing summer soccer and such a great activity during the difficult tween and teen years. Would hate other people's ability to play sports be curtailed

This sport is so well run and is a great outlet for all ages to engage in a team sport to boost their fitness, connection to community and wellbeing. Any move that restricts this will be detrimental to the community. Surely we can keep these grass fields maintained over the summer so kids and adults alike can remain engaged in something they love and brings the community together.

The very PURPOSE of a grass field is for SPORT TO BE PLAYED ON IT. Any decision by council to limit anyone, let alone children, the opportunity to participate in community sport is a gross and unacceptable misuse of power that does not align with the people that the council serve. Local sport is a foundational pillar of this community and opportunities should be expanded and more grass fields should be made available. Council needs to make clear an explanation for these plans because at this stage they are absolutely nonsensical and unacceptable.

It's amazing to see the community engagement in numbers with FootballSSG and i would hate to see children miss out because facilities are not available or suitable.

The concept of having sporting competitions effectively banned from sports fields is a paradox in itself. It begs many questions, such as who is it at the Council that makes these silly decisions and based on what expertise? Our children should be allowed to play as much sport as they wish - and no amount of red tape bureaucracy should be getting in their way!
Shame on this Council!

Let the kids play! Make more sports fields available: who needs acres of golf courses, but not enough soccer fields or basketball courts.

I write on behalf of my grandchildren's future - being able to play football is essential to their development as a whole.

I arrived in Australia and had to leave my family in the UK for 6 months. I joined SSG and made numerous new friends, without SSG I don't know what I would have done. My family arrived and me and my son continued playing for years spring and summer comps. Also nothing compares to playing on real grass, the artificial pitches are ok but should only be used as a substitute

On the northern beaches we have a lack of fields, so we all need to work together to make the most of what we have. We live in one of the most developed countries in the world and yet we have to beg for our kids to have sporting fields to kick a ball around. Something is not right. Our council should care about our kids! This is a well loved competition that brings joy to young and old. In today's world where mental issues are costing the community enormous amount of money, surely providing quality sporting fields is a small price to pay.

Let the kids play! Provide enough space for them to have some fun.

As a player of SSG Football for many years and a father who watches my kids play weekly it saddens me to think this council proposal could even be considered. Humans need to play and be active for health reasons, fitness and of course the silent killer mental health. The excitement, pride and team camaraderie that football brings to not only the players but the family and friends spectating is second to none. Lets keep kids (and adults) off screens and playing on the fields we enjoy and pay for.

My teenage son has played soccer with FootballSSG for years and he loves it playing with his mates. It would be devastating if they were unable to play and I believe detrimental to their health and wellbeing.

We need more artificial turf fields. What's is the plan for Curl Curl that is closed all the time?!

This decision is unfair to residents surrounding Narrabeen SHS as having traffic and parking chaos four nights a week is unacceptable. I would prefer they only be given 2 nights a week at the High School and be allocated another night or 2 elsewhere.

"Council needs to work with all high impact sporting groups to find a workable solution that does not impact community participation. High impact sports generally also mean shorter duration sports - meaning the utility gained from available fields for such sports is much higher than other sports - eg cricket, where two small teams occupy an entire field for hours. Im not sure of exact numbers, but hundreds of high impact participants could play on the same field over a similar time frame. Summer soccer isnt just populated by winter soccer players. My experience is that it also attracts players who, either for fitness levels, anxiety or other commitments (including of their parents), do not want to play winter soccer. Its important we don't take this opportunity away from them. At the least, Council should consult on a forward plan to move to artificial pitches over a number of years and develop a transition plan that does not impact participation levels of high impact sports."

Parking around north Narrabeen is already extremely tough and I think councils decision will only make this worse.

Current crowds and parking issues are already a huge problem at North Narrabeen.

Leave it alone!

Summer Soccer is the highlight of my son's sporting year and has been for over 8 years. To take this away for some short term preservation of pitches is apparently being decided by people who don't have children who play in this competition. Teenagers need sport to stay healthily engaged and this proposed shutdown will possibly break that continuation and be highly disappointing for them and socially damaging.

I'll be raising parking with council.

Access to sport is essential for the physical and mental well-being of a community. SSG provides access to football games of all skill levels outside of the winter season and should be enabled to continue with suitable grass fields.

We participated in Football SSG competition for many years, it became a regular part of my kids sports activity. We playing winter soccer and summer soccer and I can't imagine that this would change.

Sports are a big part of the northern beaches community. The kids require more fields not less. It's disappointing the response from the council.

Never should children's sport be limited it's so important for there over all health and feeling of community

I have 2 children who play what you class as high-intensity sports multiple times a week. They live for their participation in these sports, and a chance to play with their mates as well as keeping themselves fit. I am strongly opposed to any decision to reduce the number of grounds for any sport, or to reduce the number of people who can take part. We should be actively encouraging as many kids to play as many sports as possible!

FootballSSG is non profit & also supports female & male youths in sport!! It's vital: plastic turf is not great for the environment it has plastic water run off & it's toxic to smell. It also is slippery and not natural. This is very concerning to our environment

Please allow our children to play soccer on suitable soccer fields.

I am a 55 year-old mother of two who has been playing small field women's over 35 Soccer with SSG for many years. The small grass field suits older people playing sport and playing on turf is difficult due to the speed of the game. I believe the access to grass fields is essential to enable children as well as adults to continue their sporting pursuits. It is fun and good for our mental health to continue sport into our 50s and 60s.

SSG sport is great for the kids and adults, gets them outside, playing as a team and being social.

Football is really good and helps me

My husband plays touch and AUA Tag and it is his life line to health and community. If he couldn't play he would get more migraines and worse mental health.

My 11 year old is hypermobile and the only active group team sport he can play is touch and he waits all year to play this .. it is detrimental to health health both physically and mentally

The increase in sports across all disciplines by rate payers and their families, needs to be supported by the council. a long term plan of how to provide fields and maintain the standard of these fields needs to be discussed by Council. The Greens council representative Miranda has said she would never support artificial turf fields. Her decision is in direct conflict with a lot of the rate payers. Council need to speak to the sport associations, the community groups - including schools who would utilise these facilities also and come up with a long term plan for The Northern end of the council area. Rather than spending millions on tourists for Manly!

Our girls have played Football SSG for over 10years. It's a fantastic, fun way to keep them active, and connected with their friends from other schools now that they're in high school. Football SSG is a bit for profit that should be supported.

We have been living with this synthetic field for a number of years. There is limited street parking for the amount of cars on week days and weekends using this facility. It's not just the oval but school traffic as well. Parents/users of the oval park illegally on footpaths and in no parking/no standing spots, stopping in driveways and speed is also a concern as well as there are always pedestrians around.

All participants should be able to enjoy their weekend sport.

Council needs to come to an agreement with the sporting groups. The street won't take more parked cars at these times.

The use of synthetic surfaces only is not ideal for growing players as the pitches are usually of hard compound which is not suitable for developing joints.

Synthetic fields generate a lot of excessive heat over the surface areas especially in the warmer months.

My boys have played in the SSG Warriewood comp for 6 years now and love it. It is very well run and is a great add on to my boys sport after the winter soccer comp finishes. It is keeping my boys active and out playing sports with their mates. Please don't let kids miss out.

FootballSSG is a fantastic community sport that is well run and provides a fun, healthy and enjoyable environment for everyone. Our family have been fortunate enough to have played in a few competitions over the past few years. We catch up with friends and my son and husband thrive playing in this summer soccer tournament. I feel that taking the natural grass grounds away from our community will hinder the mental, physical and social development that this sport provides. I understand there are futsal courts and indoor soccer fields but non are like SSG. Rules and guidelines are different. And to play on synthetic grass in summer is extremely hot for both players and spectators. Stuart is dedicated and passionately invested in SSG. This shows in his expressive and detailed emails when organising each season. I personally don't understand why the council has made this decision. Open natural grass fields are meant to be enjoyed by our all in our community and I can't imagine why maintaining a beautiful grass field where no one can use would be preferable. Any sport we have on the beach's will have heavy foot traffic and SSG offering to help maintain it it thoughtful and fair. Let's please rethink this decision and not make it one we regret down the line. Appreciate your consideration.

Summer Soccer was a huge part of my sons younger life growing up, a great way to play with friends, keep active and stay connected. This opportunity shouldnt be taken away or restricted. I have three children who have all benefited greatly from FootballSSG, they will miss it terribly if it can't continue.

Totally unacceptable - and no proposed action from council to resolve the issue. Removing a healthy sport option for kids and youths is unfathomable. Along with the opportunity for young kids to ref, learn new skills and earn a few dollars.
